#### **CASE 01 CONTEXT**

Situation: external and internal issues influence the strategic direction and the overall performance of the organization

Challenge: how can we understand the influence of external and internal issues?

Solution 1: regularly monitor and review issues

Solution 2: determine the positive or negative influence of each issue

Solution 3: use SWOT and PEST tools

All these activities are very useful for analyzing the context

### **CASE 02 STAKEHOLDERS**

Situation: many stakeholders are concerned by our OH&SMS Challenge: how do we identify our OH&SMS stakeholders?

Solution 1: identify our legal requirements concerning stakeholders

Solution 2: draw up a list of stakeholders who may be affected by our OH&SMS Solution 3: draw up a list of stakeholders who can be influenced by our OH&SMS

On the contrary, some stakeholder requirements may be adopted and then become internal requirements of our OH&SMS

Drawing up a list of the stakeholders concerned and over whom our OH&SMS can exert influence is an essential activity in establishing our OH&SMS

### CASE 03 SCOPE OF THE OH&SMS

Situation: we need to maintain the scope of the OH&SMS in the form of documented information (procedure)

Challenge: what must we do to determine the scope of the OH&SMS?

Solution 1: take account of the corporate context and culture

Solution 2: include all sites, processes, products and services in the OH&SMS

Solution 3: include process mapping and process owners

The activities of the first two solutions are useful for determining the scope of the OH&SMS ISO 45001 does not require process mapping and process owners to be included in the scope of the OH&SMS
